Independent Examiner's Report to the Members of the Helensburgh Amateur Swimming Club

I report on the financial statements of the Helensburgh Amateur Swimming Club for the year ended 31st May 2018 which are set out on the attached pages.

Respective responsibilities of Club officers and Examiner

The clubs Treasurer is responsible for the preparation of the accounts in accordance with the Clubs Constitutions, Bye-Laws and Regulations (BL3.2) It is my responsibility to examine the accounts as required under BL3.8 of the Clubs Constitution and to state whether particular matters have come to my attention.

Basis of Independent Examiner's Statement
